**RESOLUTION**

WHEREAS, the Cliffside Park Board of Education applies for annual funding through the Schools and Libraries Program of the Universal Service Fund, commonly known as the “E-rate” Program, which provides discounts to eligible entities for eligible telecommunications services, which includes Internet access services.

WHEREAS, the Educational Services Commission of New Jersey (“ESCNJ”), in its capacity as a consortium, posted Form 470 number 180002185 in accordance with E-Rate Program rules to solicit bids from telecommunications service providers to provide Internet access and wide area network services commencing on July 1, 2018.

WHEREAS, the School Business Administrator Louis Alfano has reviewed the ESCNJ award and hereby recommends that the Board approve a 60-month contract with Altice Business Services, d/b/a Lightpath, to provide the following services:

- Two Gbps of Internet access service at a monthly recurring cost of Two Thousand Five Hundred and Nine Dollars and eight cents (\$2,509.08); and
- Five 1Gbps WAN connections at a monthly recurring cost of Eight Hundred and Fifty Dollars (\$850) per connection.

Under the terms of the award upon which this recommendation is based, the District may upgrade its bandwidth speed for Internet access service within the original term of the agreement without financial penalty or the commencement of the new agreement.

NOW, THEREFORE, BE IT RESOLVED, that the Cliffside Park Board of Education has considered the recommendation and hereby authorizes the School Business Administrator to execute a 60-month contract with Lightpath for the above services at an aggregate monthly recurring cost of \$6,759.08.
